11. What is THE most important issue facing the Marco Island City Council today and how will you address it?

Water Quality - I recognize how important the quality of the water in our island waterways is to our residents. The majority of us live on or very close to our canals, bays, rivers and beaches. Over the last few years, our City has commissioned several scientific studies that provide a solid foundation for policy-making going forward. I am listening to all voices: the academic scientists, our Waterways Committee members, boaters, sports fishermen, and everyone who lives on and enjoys our waters. We I am currently working on a number of proposals for science-based programs that can be implemented locally. I am committed to providing the leadership to implement those programs and policies in order to improve the quality of our waterways for our residents in a most cost-effective manner.

Short Term Rentals – My goal is to balance all property owners' rights while prioritizing residents' right to the peaceful enjoyment of their homes. My goal is to implement reasonable and equitable rules and limits with a focus on suspending licenses for chronic offenders to eliminate problem STRs on the island. Alongside oversight, it is essential to enhance enforcement efforts. I recommend that code enforcement officers be the primary responders to violations of noise, parking, and trash ordinances.
