

Who's Running for Florida's 19th Congressional District in the 2026 General Election

Republican Jim Schwartzel, Democrat Victor Arias, one NPA candidate, and one write-in candidate are competing for Florida's 19th Congressional District seat, which covers parts of Lee and Collier counties, in the Nov. 3, 2026, general election. Registered voters in the district will decide the race. The winner will serve a two-year term in the U.S. House of Representatives.

In this post, I summarize the backgrounds and stated priorities of the two major party candidates seeking this seat, along with their endorsements, recent news coverage, and campaign finance data, to help voters prepare to cast their ballots. Jim Schwartzel

Republican Jim Schwartzel is a lifelong resident of Southwest Florida who graduated from Bishop Verot High School. He is President of Sun Broadcasting, Inc. and Gulfshore Life Media, LLC. The two media organizations own and operate numerous local radio, TV and publishing businesses. These include 92.5 FOX News, a conservative talk radio station, Gulfshore Life Media, which publishes Gulfshore Life and Gulfshore Business magazines, and The Naples Press. He is married to Carly Schwartzel, his high school sweetheart; they have two children, one attending Stetson University and the other enrolled at Florida SouthWestern State College. Endorsements

No endorsements were listed on Schwartzel's campaign website as of Sept. 7, 2026. (jimforcongress.com)

In addition, President Donald Trump gave Schwartzel his "complete and total" endorsement on Sept. 2, 2026, calling him a "MAGA Warrior." ([Gulf Coast News and Weather](#)) House Majority Leader Steve Scalise and Judiciary Committee Chairman Jim Jordan endorsed Schwartzel during the Republican primary, as did former U.S. Reps. Victor Arias

Democratic Victor Arias received a Bachelor of Arts from Hamilton College in Clinton, NY, and a Juris Doctor degree from the State University of New York at Buffalo. He has been the owner and managing attorney of Arias Law Firm since 1992, representing working families in personal injury, workers' compensation, and school law cases in Southwest Florida. He ran unsuccessfully for Lee County Superintendent of Schools in 2024. He is a member of Leadership Florida (Class XIII), Leadership Lee County, Leadership Cape Coral, and Leadership Estero, and has been a member of Covenant Presbyterian Church since 1999, where he serves as an Elder and on the Board of Trustees. The Florida Democratic Party congratulated Arias as the Democratic nominee following the primary, and Lee County Democrats also endorsed him. ([FlaDems on X](#))

In Florida, the name of a qualified write-in candidate does not appear on the printed ballot.

Campaign Finances

Jim Schwartzel had less than 1 percent of receipts from small-dollar contributions of less than \$200, the FEC threshold for itemized donor disclosure. Seventy-eight percent of his itemized individual contributions came from Florida donors; 22 percent came from out of state.

Victor Arias had seven percent of receipts from small-dollar contributions. Ninety-eight percent of his itemized individual contributions came from Florida donors; two percent came from out of state.

In addition, independent expenditures against Schwartzel as of July 29, 2026, included \$7,000 by Save American Freedom. No Super PAC independent expenditure activity was identified for Arias as of July 29, 2026. Independent expenditures are not coordinated with candidates and are not included in the campaign finance totals above.
