

Who's Running for Florida Attorney General in the 2026 General Election

James Uthmeier (R), the incumbent, and Jose Javier Rodriguez (D) are running for Florida attorney general in the Nov. 3, 2026 general election. Uthmeier was appointed to the office by Gov. Ron DeSantis in early 2025 and is now seeking his first full term; Rodriguez is a former Florida House and Senate member and former U.S. Assistant Secretary of Labor. The winner will serve a four-year term as Florida's chief legal officer, overseeing the state's Department of Legal Affairs and representing Florida in litigation, criminal appeals, and consumer protection matters. In this post, I summarize the backgrounds and stated priorities of the two candidates, along with their endorsements, recent news coverage, and campaign finance data, to help voters prepare to vote. I also include links where you can research each candidate further.

James Uthmeier

Republican incumbent James William Uthmeier was born Nov. 25, 1987, and is a native of Destin, Florida. He graduated from the University of Florida and earned his law degree from Georgetown University Law Center in 2014. He worked as an associate at Jones Day, a large international law firm, before joining the Trump administration. ([Wikipedia](#); [Campaign website](#))

Uthmeier served as counsel to Donald Trump's 2016 campaign for President and was appointed by the President to serve as a senior advisor and counsel to U.S. Secretary of Commerce Wilbur Ross, working in the Commerce Department from 2017 to 2019. He joined Florida Gov. Ron DeSantis' office in 2019 as deputy general counsel, was promoted to general counsel in 2020, and became DeSantis' chief of staff in October 2021, a role he held until his appointment as attorney general. From 2023 to 2024, he served as campaign manager for DeSantis' unsuccessful 2024 presidential campaign. ([Wikipedia](#))

Gov. DeSantis appointed Uthmeier as attorney general to succeed Ashley Moody, who was appointed to the U.S. Senate. He was sworn in as Florida's 39th attorney general on Feb. 17, 2025, at age 37, becoming one of the youngest state attorneys general in the country, and is now running to seek a full term. Uthmeier and his wife, Jean, have three young children. ([Campaign website](#))

Platform

Uthmeier's campaign website does not have a dedicated Issues or Priorities page; his platform is drawn from the campaign site's framing and his record as sitting attorney general. The campaign describes him as "a dedicated public servant who has devoted his career to fighting for freedom." It says he helped Gov. DeSantis "deliver widespread victories on education freedom, parental rights, election integrity, tax relief, and public safety," that he "fought to keep Florida open during the COVID pandemic," and that he "led Florida's legal battles to immediately reopen businesses and schools and prohibit mask and vaccine requirements." As attorney general, Uthmeier has directed state law enforcement to continue enforcing a Florida immigration law after a federal judge blocked it, proposed and helped open the "Alligator Alcatraz" immigration detention facility in the Everglades, opened an investigation into JPMorgan Chase over alleged "de-banking" of Trump Media, reopened a state investigation into Raul Castro's role in the 1996 Brothers to the Rescue shutdown, argued publicly that surrogacy is "modern day slavery," issued a multi-state subpoena to Dr. Anthony Fauci over alleged COVID-era "self-dealing," and sent a letter demanding six years of internal records from The New York Times Co. Legal Matters

A Florida grand jury report, sealed since January 2026 and made public in August through litigation and news reporting, found that \$10 million from a 2024 Medicaid settlement with Centene Corp. was “misappropriated” and funneled through the Hope Florida Foundation, a charity associated with First Lady Casey DeSantis, into political committees that spent it campaigning against a 2024 ballot measure to legalize recreational marijuana. The report found Uthmeier, then Gov. Ron DeSantis’s chief of staff, personally directed a recipient organization to apply for a Hope Florida grant and held “a position of authority” over how the funds were used once they reached the committees, but the grand jury found insufficient evidence to charge Uthmeier or anyone else criminally. Uthmeier has said he was never a target or suspect in the matter and has called it a “nothingburger”; DeSantis has called the investigation a hoax. In June 2025, U.S. District Judge Kathleen M. Williams held Uthmeier in contempt of court for continuing to direct state law enforcement to enforce a Florida immigration law after she had blocked it in a prior ruling. Uthmeier said he would not tell law enforcement agencies not party to the case to stand down, and that if the judge chose to jail him over it, “I’m willing to take that.” ([The Guardian](#); [Florida Politics](#))

Jose Javier Rodriguez

Democrat challenger Jose Javier Rodriguez was born Aug. 8, 1978, and grew up in Miami. His father fled Cuba as a teenager during Operation Pedro Pan; his mother’s family has midwestern roots. He received a B.A. in international relations from Brown University in 2000, served in the Peace Corps from 2000 to 2003, and earned

his J.D. from Harvard Law School in 2006. ([Wikipedia](#); [Ballotpedia](#); [Campaign website](#))

Rodriguez was elected to the Florida House of Representatives, District 112, in 2012 and was reelected in 2014. In 2016, following court-ordered redistricting, he ran for the newly created Florida Senate District 37, defeating incumbent Miguel Diaz de la Portilla, and served in the Florida Senate from 2016 to 2020. He briefly sought the Democratic nomination for Florida's 27th Congressional District in 2018 before withdrawing. In 2020, he narrowly lost his re-election bid for Senate District 37; news investigations later found that a spoiler candidacy in that race was funded by dark money connected to a former state senator who was arrested in connection with financing it. In 2021, President Biden nominated Rodriguez to serve as Assistant Secretary of Labor for Employment and Training at the U.S. Department of Labor. The nomination was confirmed on March 21, 2024, and he served in the role from April 2024 until Jan. 20, 2025. ([Wikipedia](#))

Rodriguez married Sonia Succar Ferre, granddaughter of former Miami Mayor Maurice Ferre, in 2014; they have two sons. He launched his campaign for attorney general on June 2, 2025, saying he wants to be the "people's lawyer." ([Wikipedia](#); [Campaign website](#); [Florida Phoenix](#))

Platform

Rodriguez describes his candidacy in first-person terms on his campaign website: "Now running for Attorney General, I'm committed to bringing stability back to the office – serving as a steady, professional enforcer of the law, not a political operation. I'm focused on keeping Floridians safe, fighting to lower costs, and rooting out corruption, all while serving as a fair, independent advocate for all Floridians, not special interests."

His campaign website lists these stated priorities ([campaign website](#)):

- Provide relief for homeowners and small businesses from sky-high insurance rates and rising fees.
- Crack down on corruption and fraud in both the public and private sectors.
- Hold powerful corporations accountable when they hurt Florida families.
- Serve as an independent voice for the people of Florida.
- Support law enforcement.

- Defend our rights.
- Tackle the fentanyl crisis.
- Take on scammers.
- Protect minors and the most vulnerable.

Campaign Finances

Political committees may raise and spend money without limit to support or oppose candidates, but Florida law caps direct transfers from a committee to a candidate’s own campaign account at \$3,000 per election, with the primary and general treated as separate elections. James Uthmeier’s Contributions

Uthmeier raised \$1.8 million from 1,336 individual and institutional donors. Eighty-nine percent of his monetary contributions came from within Florida. He received \$131,250 from 54 political committees, most at the \$3,000 per-election maximum, representing business, insurance, real estate, legal, and law-enforcement interests, including two Florida Chamber of Commerce PACs and the Florida Police Benevolent

Association. The Republican Party of Florida also provided \$241,138 in in-kind support across 89 transactions.

Separately, Friends of James Uthmeier, a political committee he chairs, has raised \$10.1 million since its formation, of which \$8.9 million remains available.

Jose Javier Rodriguez's Contributions

Rodriguez raised \$1.2 million from 1,958 individual and institutional donors. Ninety-two percent of his monetary contributions came from within Florida. He received \$66,850 from 40 political committees, most at the \$3,000 per-election maximum, the majority representing labor unions, including several IBEW, Teamsters, and SEIU locals. The list also includes two probate and estate-planning law practitioner committees and several Democratic Party county and legislative committees. The Florida Democratic Party separately provided \$47,216 in in-kind support across nine transactions.
